Subject: Authorization to Carry Firearms

Attached is a list of individuals who have completed firearms safety training and proficiency testing in accordance with the BLM Manual H-1112-1. Having completed those requirements, they are hereby authorized to carry, while on official duty, weapons for protection from wild or dangerous animals, for the emergency taking of food, and for signaling purposes in a survival situation. All weapons and ammunition utilized for official duty purposes must be in conformance with the requirements set forth in BLM Manual H-1112-1 and AK IM 2010-016.

Individuals utilizing firearms for official duty purposes are responsible for full compliance with all local, state and federal regulations pertaining to the use, transportation, and storage of firearms and ammunition. Individuals who kill an animal in Defense of Life and Property (DLP) while in the field for official duty will comply with all state laws governing DLP reporting procedures and the processing and disposition of the animal's body.

This authorization is contingent upon approval from each employee's manager, or supervisor after a determination that the carriage of firearms is a duty requirement and the individual exhibits appropriate personality or behavior for the safe use of firearms. Managers and supervisors are responsible for monitoring employee conduct to ensure that firearms safety is maintained and official use is authorized. The authorization is valid until the end of this calendar year.
