8/19 Mississippi Fire #117

Cooler temperatures and intermittent rain have helped to slow activity on the 67,711-acre Mississippi Fire near Delta Junction. Crews continue work to secure the area north of the fire to protect the Whitestone community and other values at risk. 8/19 Birch Creek Fire #506

Fire officials continue to monitor weather conditions on the 24,923-acre Birch Creek Fire to determine if there will be an opportunity to complete a burn out operation. The fire is burning 5 miles southeast of Circle Hot Springs. In the meantime, crews are working on fire mitigation projects in the area. 8/19 Tetlin Jct. Ridge Fire #414

8/19 Stuart Creek 2 Fire #280

Fire managers continue to monitor the 87,064-acre Stuart Creek 2 fire, burning on a military training range 25 miles east of North Pole. The Temporary Flight Restriction over the fire has been lifted.

8/19 Tabert Lake Fire #625

Activity on the 1,360-acre Tabert Lake Fire has decreased after wetting rain over the weekend. The Temporary Flight Restriction over the fire has been lifted. Hunters – Please Be Careful with Your Campfire



With the start of hunting season, hunters and other backcountry travelers are urged to be extra careful with campfires and with anything that could start a fire. While rain has fallen in portions of the Central and Eastern Interior, vegetation remains dry in many areas. Remember: You are responsible for every fire you start. *Make sure your campfire is dead out!*

Attention Pilots

Four Temporary Flight Restrictions are in place over fires burning in Alaska. Please check for TFRs at <http://tfr.faa.gov/tfr2/list.jsp>

Fires that do not have a TFR in place may still have aircraft working in the area. Please stay at least 5 nautical miles away from ALL wildland fires to keep the airspace safe.
