National Update: NMAC Liaison

- NMAC: meeting once a week and moving to meeting twice a week (Mon & Fri)
- Rest of country still drying out, no significant fires/danger/threat other than Alaska
- Great Basin in PL2 reluctant to release any resources, SW discussing going to PL1
- Admin session, relayed concerns regarding SMKJ and crews
- NMAC and NICC are committed to Alaska needs
- SMKJ UTF discussion, suggestion to bring NICC in the loop at the beginning to avoid confusion and ensure all are on the same page
- Willingness to order lower 48 teams
- NICC agreed to fill two loads, coming up with no expectation of crews returning
- Looking around Nationally on how to align SMKJ's with needs down there
- Looking at potential to have jump ship and boosters, in will know more tomorrow

Weather Update: AICC Met

- Lightning activity on the rise for this week
- Yesterday had a cell South of Glenn Hwy by Mat-Su area that didn't move and over 400 strikes
- Expect to see more action like that in the next few days
- Wednesday looks to be biggest potential for lightning
- Initial Attack should increase towards the middle of this week
- No significant wetting rains in the long range future

Fuels Update: AICC Analyst

- Fire activity confirms what we've been talking about
- Northern part should see some pretty spectacular fire activity
- Burning index is comparable value
- Across Upper Yukon zone down through southern Tanana zone down through SW shown pretty spectacular fire activity and conditions
- Tanana Valley conditions are not quite as extreme and more manageable

AICC Update: AICC Rep

- 26 SMKJ in Fairbanks, 8 still in Galena and the 8 in McGrath are not responding to a fire by Lake Iliamna
- Jump 63 headed to Frozen Calf
- Moved air attack and 4 fire bosses to Galena
