PI 5, light IA, 15 news fires, 319 acres, 9,100 acre growth on 215 active fires

4 tanker, 4 scooper, 3aa, 3asm or lead, 3 bd, 6 fb, 4 loads of jumper - 2 fbx, 1 in mcgrath, 1 in galena, receiving 10 more boosters tonight

311,722 acres, 0%, 231, \$2.8 million

Moderate fire behavior, smokey over much area, gain of 6,500 acres, no rain, chalk completed plumbing and improving indirect from town to Odid lake

6 miles to ne, crews tied in natural barriers to protect remote cabins and allotments on black river, both areas have large areas of black spruce leading into improvements on black and chalkf Later today start firing ops, on onorth between bearnose and black river, 15,000 acres, large operation, 1600 star

New fire located ne, 70 miles from chalk, #549, 6 miles from Canada, nothing threatened Interfacing with community, on radio every day

11 a.m. agency admin meeting today,

Safety concerns – increase in bear sightings, smj lost packraft to bear, boat usage, heat related injuries with crews

Another good day, sun came out and some spots showed new life, able to map and see where problems

Cold and cloudy today, supposed to be breezy and sunny, that's when have problems so see what happens

Some rain last night, heavy around 2100,

Asked for IR flight, some confusion in Fbx area, put in request early morning and didn't find out until late night weren't going to get it, pilo

Needs – one t1 or t2ia crew, talk about extending 2 crews on fire, if that happens won't need additional crew, if they go home they'll need another crew in 3 days

Got some additional engines, releases ia stuff back to fbx area,

Keep it at t3 with new ic coming in Sunday, suppression repair

Schmoll will see if can get dirti bird ship and will talk to fbx area about it, and crews are being extended

8700 acres, 0%, 95, \$530,000

Do have dirti bird flight scheduled today, didn't happen yesterday

Same conditions, real smokey, moderated behavior, backing to sourth, nothing major in terms of fire beh, still holding on alder creek, completed some structure protection around fish camps on alder creek in event need to burn out, looking at native allotments further up the river, assessing, took Garnet creek over, 0700, 500 acres, monitoring by air, 8 miles from nearest value at risk, hasn't grown much

Community meeting today at 1500, no closures or evacs or public safety issues

Bee sting a couple days ago, delayed reaction yesterday, swelling, small laceration on finger on bed of truck;

No needs – releasing 8 smj today, timing out
