- Clarified that "non-aviation" resources will have completed and signed fire time reports before being released from an initial attack response (III.B.7. Mutual Support).
- Added new section on DOF Health and Wellness Program (III.B.12).

IV. Preparedness:

• Updated Table 3: Interagency Preparedness Planning Schedule:

- Added new Spatial Fire Planning Service and changed annual updates/review from March 15 to April 1.
- Changed CAD system updates from March 15 to April 1 to align with data product availability.
- Changed Alaska Wildland Fire Jurisdictions data submission to new Data Management Program.
- \circ Removed AISRM completion from May 1 (was duplicate of April 15).
- Added "or 3rd" week of October for Interagency Fall Fire Review.
- Figure 1 (map of Alaska Wildland Fire Protection Areas) updated.
- Added language to clarify that the USFWS/Air Force program has no wildfire suppression or fiscal role on Air Force lands in Alaska (IV.B.1.e).
- Added four new NWCG fire type categories (i.e., structure fires, vehicle fires, debris/product fires, and foreign incidents) that require notifications from the Protecting Agencies to the affected Jurisdictional Agencies (IV.C.3).
- Added link to the ADF&G Fish Habitat Permit (IV.C.3).

- Removed outdated BC & NW US Wildfire Response Border Arrangement Operating Plan (pdf) and clarified the public law references for the Canada/US Reciprocal Forest Firefighting Arrangement (V.B).
- Updated required Fire Cause fields for Coal Seam/Oil Shale fires (V.D.8).
- Updated Invasive Species Control section (V.D.9).
- Added DNR contact for Post-fire Response (V.D.10).
- Added Red Book requirements for WFDSS decisions and clarified decisions should only be completed for wildfires, escaped prescribed fires and potentially foreign incidents (V.E.1).
- Clarified DOI cost thresholds for WFDSS approvals in Tables 5-7 are for estimated final cost (V.E.4).
- Added brief description of Decision Support Centers (V.E.5).
