Narrative: The fire was initially called in by a Stevens Village citizen at 1/2 acre and smoldering in white spruce, upriver from the village and within 150 yards of a structure. 1 load of smokejumpers was requested. Jumpship 17 was dispatched to the fire and deployed 8 smokejumpers. The fire was sized up at 1/10 acre and exhibiting minimal heat. IC Duning reported updated activity as having a 60% active perimeter, smoldering and creeping in tundra and brush with no visible flame. Containment of the fire was at 16:30. At last report the smokejumpers were gridding the fire. Demobilization of all personnel is scheduled for 9/14.
