The fire was reported by a private aircraft to the Tok Forestry office at 1735. Copper River Area was notified that the fire was located 17 miles NE of Lake Louise in their response area. Helitack 212HL, four fire bosses and a load of smokejumpers responded to the First Lake Fire. The fire was sized up as 5 acres creeping with single tree torching in black spruce. The fire plotted in a limited suppression area, however a non-standard response was initiated due to the proximity to full protection and structures located 4 miles to the South East. Personnel got saw line around the entire fire and hose most of the way around to achieve 70% containment.
