Smoke jumpers were able to make good progress securing the perimeter and mopping up hotspots farther into the interior from the line. H-361EH was utilized for bucket work on the left flank while saw teams focused their efforts on the right flank of the fire. Cooler temperatures and very light precipitation was observed over the fire today.

The plan for tomorrow is to continue mopping up and bone piling problem areas along the line and interior. Saw teams will focus on the right flank and remove hazard trees along the line.

Fire exhibited active behavior on all sides due to dry fuels and a north wind. The fire was actively burning into late evening. Firing operations were completed on two allotments with some holding concerns late into the evening. Heavy smoke hampered ground lookouts and relied on fixed and rotor wing aircraft. Zulu Group identified pre-existing fire lines from the Long Lake Fire that can be used as alternate/contingency lines if needed. Additional Management Action Point and two new control lines were identified. Fire received critical overhead needs and now has 132 personnel. Perimeter mapping mission was completed. Fire is 18,406 acres.
