Upon arrival, resources discovered a 20'x20' burn pile that had escaped into the adjacent wildlands. Unified Command was established with Butte Fire. A full suppression tactic was utilized to reach containment at 1627.

Upon arrival, resources reported a 5x5' fire smoldering in grass, originating from a non-compliant burn. Fire was extinguished, declared contained and controlled and left in monitor status.

Narrative from 4/20/2026: Nikiski Fire Department received a report of a tree on powerline around 1744 with potential arcing and sparking near Daniels Lake Road and Lucille Drive. Alaska Coastal Dispatch notified the Forest Management Officer who requested that a prevention office head that way. As prevention was headed there, they requested a type 6 engine to assist. When Nikiski Fire Department arrived on scene they reported no arcing and sparking and notified the homeowner was aware and departed the scene. The type 6 forestry engine was told to stand down by the Forest Management Officer and the prevention remained en route. Upon arriving on scene, Prevention found a cottonwood leaning on a powerline. Homer Electric Association arrived on scene and cut power to the line so prevention could conduct their investigation. Prevention found 0.1 acres of burned area associated with the tree. The fire was called contained and controlled at 1908 and resources will continue to check as they progress towards calling the fire out.

The fire was estimated at approximately 0.10 acres in spruce and was contained and controlled at 2313.

Narrative from 4/19/2026: P671 arrived on scene to find a white spruce tree hanging on a powerline. Investigation determined the tree had been cut with a chainsaw. The incident occurred on private ownership within the KKS protection boundary, and critical Management Option.

E664 arrived on scene at 10:19 and provided a size-up, assuming IC. Homer Electric Association arrived at 11:17 and removed the tree from the powerline. Command was transferred to Prevention 671 when E664 was dispatched to a reported structure fire at 11:51.

Prevention 671 evaluated the area after the tree was removed and identified approximately 0.1 acre of burned area associated with the tree. The fire was reported contained and controlled at 11:55, and Prevention 671 cleared the scene.

One engine responded and reported a 5' x 5' fire consisting of mixed hard wood slash and debris that had ignited from an earlier reported vehicle fire. Forestry personnel extinguished the fire and called it contained and controlled at approximately 1200. The fire was placed in monitor status.
