Their initial size up put the fire at 1-2 acres, with a 60% active perimeter burning in tundra and spruce. Later in the afternoon a detection flight was moving through the district and provided an updated size of 3-5 acres, advising that the fire was smoldering, creeping and backing along, but that the primary source of smoke was the consumption of fuels within the fire's existing perimeter as opposed to from new growth. Fire managers will continue to monitor the fire to determine if an additional response is warranted.
