Narrative from 8/18/2026: The fire remains actively burning in and north of Tok, Alaska, a critical community located at the junction of the Alaska Highway and Tok Cutoff and a primary transportation and supply corridor between Alaska and Yukon, Canada. Approximately 450 structures are threatened, with additional concerns from damaged structures, hazardous materials, public interaction, and potential impacts to the Alaska Highway.

The fire is approximately 5,077 acres and 16% contained, with 167 resources on scene. Suppression and structure-protection resources increased significantly today, with support from the Alaska State Troopers, Alaska Department of Transportation, Alaska State Parks, Mat-Su Borough, Copper River Borough, Fairbanks North Star Borough, Anchorage Fire Department, Girdwood Fire Department, Chugiak Fire Department, and U.S. Wildland Fire Service. Engines from Kenai, Copper River, Fairbanks, Palmer, and Delta Junction also arrived, along with multiple dozers and water tenders. Mat-Su Borough provided three Type 6 engines and a command vehicle.

Two airtankers completed retardant drops today. Scoopers 284 and 286 (CL-215s) will RON in Whitehorse while clearing customs and are expected to be available tomorrow morning. T-183 and T-168 arrived today; T-186 also arrived today. T-164 will require August 19 off, and T-183 will require August 20 off.

Alaska Complex Incident Management Team 1 has filled its order with 24 core resources. Command and General Staff have mobilized to Tok. The team will shadow the current organization on August 19 and assume command at 0700 on August 20.

Responders will continue prioritizing defensive operations within the community of Tok, securing fire within the community and protecting structures from continued spread. This priority may limit the ability to check perimeter growth to the north and east in the short term. Structure-loss assessments remain ongoing.
