It was a busy day moving supplies, mobilizing three crews and demobing two crews. Crews on Ohtig Lake allotments continue deep mop-up and have secured line to 20 ft. Trees have been falling. Mop-up continues around structures B3 and B4.

Fire #687 has a hoselay in place and is burning deep. Acreage unchanged at 34 acres.
