Rank 2, 100 % active, creeping and running on the tundra and spruce. 1-2 foot flame length, winds 10 miles out of the south east. Fire is on a flat aspect, structures not immediately threatened but there are multiple structures on the south side of the lake. A/A recommended that fire bosses 241/243 divert to fire from 751. Tanker 42 was ordered along with T40. 120SH brought a load of helitak personnel and started bucket work. Fire continued to grow with the winds pushing it in different directions. Once jumpers became available, they were requested and jumped the fire with 8. The smokejumpers will remain on the fire overnight. Fire is calculated at 100 acres at the time of this report.

The fire was reported after hours on 8/18, 2.5 miles outside the village of Levelock with strong north winds. Locals responded and worked through the night to put in a dozer line around the community. The fire grew overnight in a straight path north to south, running alongside the village. Residents began self-evacuation of elders and children due to the heavy smoke. J-07 responded to the fire, deploying 8 smoke jumpers. J-07 reported the fire to be 65% active in tundra with pockets of spruce, flames 1-2' with light winds out of the west at 5 knots. Due to heavy smoke, personnel were unable to give a complete size up, acreage will be updated as visibility improves. At 2100 the fire was reported to have crossed some of the control lines and first line evacuations were in place for structures on the west side. Orders for further resources have been placed to aid in protection of the community. Forestry personnel and volunteers will continue to work into the night utilizing available equipment to protect the community and monitor the fires progress.
