The fire was reported by J-17 while enroute to another fire. The fire was half an acre, 70 percent active with flames 1 to 2 feet high, creeping in an old burn scar located 150 yards off the road. J-17 deployed 2 smokejumpers and Engine S-31 responded from McGrath with one to assist in suppression efforts. Personnel completed a saw line around the fire and are securing heat on the fire edge. The plan for the next shift is to bring the engine back on in the morning and continue gridding the fire. The fire has been declared contained and was mapped at 0.33 acres

The fire was reported by an officer from Togiak as a brush fire half a mile northwest of town. A load of smokejumpers was requested to assist locals in suppression efforts. J-17 responded from Fairbanks reporting the fire to be approximately 2 to 5 acres, 15 percent active, with flames 2 to 4 feet, backing away from the village. Personnel tagged in with the locals and were able to get around and contain the fire. Plans for the next shift are to continue gridding for heat with tentative demobilization in the afternoon of August 16th.
