



## 2025 Alaska Interagency Incident Management Team Application Process

---

The Alaska IMT will accept 2025 applications through the Alaska IMT Application System at <https://forms.office.com/g/6B9DkqPxLA>. No account or login is required. You will be asked for supervisor contact information and will be required to certify that they approve your IMT application, but supervisors will not receive emails asking them to approve applications. You may apply for up to four positions on a single application. To apply for additional positions, you will need to submit an additional form and re-enter supervisor information as well as agency, dispatch, and contact information. You will see a Thank You screen if your application has been successfully submitted. You will **NOT** receive an email confirmation. Before you apply, make sure you have the following information available:

- Your supervisor's name, email, and phone number
- Your name as it appears in IROC (optional, but valuable information for rostering teams)
- Your mobile phone number, primary email address, and FireNet email address, if you have one.
- The agency you work for, your employment status, and the Unit ID or name of your dispatch center.
- The position(s) you wish to apply for and the type of application (Primary, Shared, Alternate, Trainee)
- If you apply for a Shared position, be prepared to identify who you plan to share the position with.
  
- Passport status (to facilitate international mobilizations)
- S-520, CIMC, CIMT Field Evaluation Status

Note: Alaska intends to utilize the CIMT model for the 2025 fire season in line with National direction. Our goal is to develop standing rosters for three CIMTs.

Type 2 certified personnel should continue to pursue CIM qualification. Pathways include:

- NWCG CIM Field Evaluation (through 2024) or
- Completion of S-520, Advanced Incident Management or
- Completion of Complex Incident Management Course (CIMC).

Type 2 trainees should work with their home unit to open a CIM taskbook and update IROC qualifications to reflect the CIM position.

The Alaska IMT application system will accept both Type 2 qualified and Type 2 trainee applications for 2025; however, both will be treated as trainee CIMT applicants for 2025 unless CIM requirements are met.
