

2026 Alaska Interagency Complex Incident Management Team Application Process

The Alaska CIMT will accept 2026 applications through the Alaska CIMT Application System at https://forms.office.com/g/6B9DkqPxLA. No account or login is required. You will be asked for supervisor contact information and will be required to certify that they approve your CIMT application, but supervisors will not receive emails asking them to approve applications. You may apply for up to four positions on a single application. To apply for additional positions, you will need to submit additional forms and re-enter supervisor information as well as agency, dispatch, and contact information. You will see a Thank You screen if your application has been successfully submitted. You will NOT receive email confirmation. Before you apply, make sure you have the following information available:

- Your supervisor's name, email, and phone number
- Your name as it appears in IROC (optional, but valuable information for rostering teams)
- Your mobile phone number, primary email address, and FireNet email address, if you have one.
- The agency you work for, your employment status, and the Unit ID or name of your dispatch center.
- The position(s) you wish to apply for and the type of application (Primary, Shared, Alternate, Trainee)
- If you apply for a Shared position, be prepared to identify who you plan to share the position with.
- Passport status (to facilitate international mobilization).
- S-520 and/or CIMC completion

Alaska will utilize the Complex Incident Management Team (CIMT) configuration for the 2026 fire season in line with National direction. Our goal is to develop standing rosters for two CIMTs.

Type 1 and Type 2 C&G position qualifications will be archived in the PMS 310-1 in January 2026 as directed by NWCG Memo 25-002: Archival of Type 1 and Type 2 Command and General Staff Position Qualifications. More detailed information on the CIM transition and qualifications is available at Incident Workforce Development Group | NWCG.

Type 2 certified personnel should continue to pursue CIM qualification before January 2026. Pathways include:

- Completion of S-520, Advanced Incident Management or
- Completion of Complex Incident Management Course (CIMC).

Type 2 trainees should work with their home unit to open a CIM task book and update IROC qualifications to reflect the CIM position.
