Candidates must complete the online nomination form (link above) AND then send their nomination package to their GATR. Visit the Wildland Fire Learning Portal for a list of GATRs. \*\*Note you will need to login as a guest if you do not have an active account to access this information\*\*

#### Target Group / Prerequisite Qualifications

Any person seeking Complex Command and General Staff qualification(s) (Incident Commander Complex, Planning Section Chief Complex, Operations Section Chief Complex, Logistics Section Chief Complex, Finance Section Chief Complex, Safety Officer Complex, Liaison Officer Complex or Public Information Officer Complex

Individuals must complete one of the following training courses: S-420, L-481, or O-305. Nominations must be submitted with a current fire qualification record and a recommendation letter from IC or C&G staff member with a brief background of the person nominated.

Individuals must have an open task book for a Complex or Type 1 command and general staff position for the position they will be filling at the course.

#### Agency Administrator Students:

As part of their ongoing training and certification, AA will interact with S-50 student and will provide the AA perspective.

- The AA will gain a greater understanding of the challenges, interpersonal interactions and role of the AA when partnering with the C&G of an IMT.
- AA will gain knowledge and have practiced, in a simulated environment, the development of incident objectives, incident strategy, the application of policy, relationships, processes, and decision making on a complex incident.
