The threat of afternoon thunderstorms remains for the rest of the week, while dense smoke will continue to keep temperatures cool through Tuesday when possibly warmer temperatures arrive over the fire area. Resources continue to assess values at risk and implement structure and point protection and defensive actions as necessary. The Anderson Complex has acquired the Rock Creek and Bear Creek fires to the southwest.
